Last year, DEED identified the following rule as obsolete:

Minnesota Rules, part 3300.0500. Minnesota Rules, parts 3300.0500 through 3300.3050 cover Youth Employment. Part 3300.0500 is the only rule that remains in place in that area of Chapter 3300. Every remaining rule in Youth Employment has been repealed. DEED has not made use of part 3300.0500 in more than 20 years and is not aware of any other agency currently using that Rule. **Update:** DEED intends to repeal the rule part through the legislative process.

DEED has reviewed its rules and found no others that have become obsolete, unnecessary, or duplicative over the course of the last year.
