- Adverse Health Events in Minnesota: Third Annual Public Report. Minnesota Department of Health, 2007. <u>http://www.premierinc.com/all/safety/safety-share/03-07-downloads/04-mn-report-2007.pdf</u> Since 2003, Minnesota hospitals, surgical centers, and regional treatment centers have been required to report adverse health events, including falls associated with a death, foreign objects left in the body after surgery, or surgery or other invasive procedure on the wrong person or body part. The report includes adverse events by facility, and discussion of work underway to improve patient safety.
- Health Risk Limits for Perfluorochemicals: Report to the Minnesota Legislature 2007. Interim Report. Minnesota Department of Health, 2007. The Minnesota Legislature directed the Health Department to report on its progress toward determining the health effects of perfluorochemicals, which have been found in the drinking water in Washington and Dakota Counties.

This report was done after citizens, elected officials, and public health officials expressed concerns about whether community cancer rates are unusually high in communities where perfluorochemicals have been detected.

After three years, seven percent of the 3,166 offenders studied had been rearrested for a sex offense, six percent reconvicted, and seven percent incarcerated.

The authors estimate that Minnesota would have to invest \$250 million to acquire and develop a high-quality park system to adequately serve the fastest-growing areas outside the metropolitan area.
